STUDENTS APPROVED FOR CAMPUS RELEASE MUST STUDY IN A DESIGNATED COMMONS AREA OR LEAVE THE BUILDING IN A TIMELY FASHION DURING PASSING TIME. STUDENTS WHO DO NOT HAVE CAMPUS RELEASE PRIVILEGES MUST REPORT TO THE LEARNING CENTER DURING THEIR UNSCHEDULED PERIODS INCLUDING OPPOSITE THEIR ASSIGNED LUNCH SESSION.

STUDENTS WILL HAVE CAMPUS RELEASE PRIVILEGES REVOKED FOR THE FOLLOWING REASONS:

- RECEIVING AN F, F+ OR INC GRADE FOR THE PREVIOUS SEMESTER
- HAVING A FAILING GRADE AFTER THE 6 WEEK GRADE PULL
- HAVING EXCESSIVE UNEXCUSED ABSENCES FROM CLASSES
- BEING IN VIOLATION OF ANY SCHOOL RULES AND REGULATIONS
- PARENT REQUEST AT ANY TIME
